

## EAST DUNBARTONSHIRE LICENSING BOARD

### LICENSING (SCOTLAND) ACT 2005 - FEES

#### PREMISES LICENCES

Application fees:-

| Category | Premises within Category                    | Application Fee | Annual Fee  |
|----------|---|-----------------|-------------|
| 1        | See note below                              | <b>£200</b>     | <b>£180</b> |
| 2        | Rateable value between £1 and £11,500       | <b>£800</b>     | <b>£220</b> |
| 3        | Rateable value between £11,501 and £35,000  | <b>£1,100</b>   | <b>£280</b> |
| 4        | Rateable value between £35,001 and £70,000  | <b>£1,300</b>   | <b>£500</b> |
| 5        | Rateable value between £70,001 and £140,000 | <b>£1,700</b>   | <b>£700</b> |
| 6        | Rateable value over £140,000                | <b>£2,000</b>   | <b>£900</b> |

#### **Note – Premises Falling within Category 1**

Premises fall within Category 1 if:-

- (a) they are not entered on the valuation roll or there is no rateable value or a nil value shown in respect of them on the roll;
- (b) their main function is to provide a visitor attraction and any sale of alcohol on the premises will meet the following requirements:-
  - (i) the alcohol is not to be consumed on the premises; and
  - (ii) the sale of alcohol is considered by the Licensing Board as likely to be incidental to other activities carried on in the premises;
- (c) they are used wholly or mainly for the purposes of a members' club; or

- (d) their main function is to provide accommodation, they are only open to the public for the provision of accommodation and any alcohol sold on the premises is to be consumed on the premises by guests being accommodated there.

Provisional premises licence application fee - **£200**

Other premises licence fees:-

Transfer of premises licence on the application of the licence holder, including an application for variation of licence - **£140.61**

Transfer of premises licence on the application of the licence holder, not including an application for variation of licence - **£43.06**

Transfer of premises licence on the application of a person other than the licence holder, including an application for variation of licence - **£140.61**

Transfer of premises licence on the application of a person other than the licence holder, not including an application for variation of licence - **£43.06**

Application for variation of premises licence:

- (a) variation sought is substitution of premises manager and is requested to have immediate effect and any other variation sought is a minor one - **£31**
- (b) minor variation or variations not falling within (a) above - **£20**
- (c) non minor variation - **£140.61**

Application for temporary premises licence - **£140.61**

Application for extended hours - **£10**

### **OCCASIONAL LICENCES**

Application fee - **£10**

### **PERSONAL LICENCES**

Application fee - **£50**

Application for replacement of personal licence - **£15.60**
